**OBJECT :** DENOUNCMET OF OCCUPATION, DOMINATION AND COLONIZATION OF THE SARDINIAN NATION PERPETRATED BY THE FOREIGN ITALIAN STATE. CLAIMS OF SOVEREIGNTY OF THE SARDINIAN PEOPLE

With this document the **MOVIMENTU DE LIBERAZIONI NATZIONALI SARDU** (MLNS) claims the sovereignty of the Sardinian people, claims and demands the liberation of the Sardinian Nation from the illegal and unlawful occupation of the foreign Italian State.

The Sardinian Nation, historically independent from the IX to the XV century, has been prevented from exercise its lawful wright of sovereignty in its own territory caused by the occupation of the Italian state. The same state we consider foreign, colonialist and racist.

Historically the Sardinian Nation since 1409 has been submitted under the "Corona d'Aragona" occupation, in 1718 from Austria and from 1720 by the Savoy. From 1861 to this day there was "de jure e de facto" the illegitimate, illicit and violent repression, even military occupation by the foreign Italian state.

## THIS BEING STATED

This Organization of the United Nations shall mobilize, together and in accordance with this **SARDINIAN NATIONAL LIBERATION MOVEMENT**, guaranteeing the immediate cessation of the illegitimate and illicit occupation by the Italian foreign state in the Sardinia national territory.

## WE ALSO ASK

**To ensure** the immediate effective withdrawal of the occupying state with its institutions and armed forces from the Sardinian National territory

**To guarantee** the necessary institution and constitution of the Sardinian Police force and to assist it with deployment of your own observers in order to ensure free democratic elections of the Sardinian People new Institutional Organs.

**To support** even financing "ad hoc" the process of reestablishment and the reconstruction of the Sardinian Nation.

**To sentence** the Italian foreign state to refund all the occupation damages, including the war damages of the past world wars, including colonial wars and the illegitimate and unlawful fiscal levy from 1861 to the date of the effective cessation of the oversaid occupation.
