**SUBJECT: DENOUNCMENT FOR CRIMES AGAINST HUMANITY AND  
SUBMISSION TO SLAVERY OF SARDINIAN CITIZENS**

I will start by making a few clarifications:

Water is the lifeblood of all basic bio-chemical processes of cellular organisms.

It is a fundamental element of life of all living beings. So water cannot be considered an asset but an essential right to life, without it there would be no life on the planet.

Water has biological value but also an anthropological one; it generates life, determines hygiene and protects us from diseases, it is also a parameter which determines the social decorum, education and well-being.

Access to water is considered a fundamental right and must be guaranteed regardless.

This right must be expressly specified in legislative terms, it is not an alienable right because, if it were to be managed, the management itself would have to be based upon the principle of ensuring this right.

To deny water service is a deed that goes against nature, and separating it from the bio-chemical system of live, becomes a blatantly criminal action, because it deprives the individual of hygiene

and decorum. The concept can be seen as a psychological persecution and submission to slavery.

To subtract water means to inhibit healthy family development, to strengthen the incentives to murder-suicide and crime, because without, it life cannot develop.

A developed and civil society cannot deny the right to free access to water for those without means, because it is important to have respect for life, society and families.

It is responsibility of the state to administer and guarantee this right to all citizens, especially to those who are in need, interceding for those who are not able to pay the costs of water services, even limiting the private management of water because it is not a commercial product but an inalienable right of all human beings. A welfare state must take measures to promote work for everybody, to redistribute the wealth, to ensure that all citizens can live with the dignity they deserve and can thus do their part to strengthen the welfare State.

There is water in abundance for all, so we must ensure access and fruition to the underprivileged.

### the Company ABBANOVA S.p.A

- It has repeatedly demonstrated, in its management of the water system of The Sardinian Nation, its inability and incompetence of this important social task.
- It has been under investigation by the Italian foreign judicial authorities for offenses related to the management of the S.p.A.
- It has been allegedly guilty of crimes against humanity, as in the case of interruption of supply to users who, according to them, were late in their payments or facing serious economic hardships.
- It has been allegedly accused of psychological persecution against users, and the



consequent enslavement caused by depriving them of their right to physical hygiene hence of their decorum

- It did receive public money to improve services but it used it to pay its debts.
- It did not take as much care, as it should have done, about the management of the water network and was therefore forced to interrupt - for poor maintenance and inefficiency - the public service, hence burdening with improper charges, the cost of water distribution, weighing economically on the utilities.

In view of the above the Movimentu de Liberatzioni Natzionali Sarddu (MLNS), as a subject of international law, has repeatedly denounced, warned and challenged the Italian occupying State, notifying it:

- On June 4<sup>th</sup> 2012 the "DENOUNCING THE UN ITALIAN STATE FOR EMPLOYMENT, DOMINATION AND COLONIZATION OF THE "SARDINIAN NATION", claiming the right of sovereignty of the Sardinia citizens.
- On August 20<sup>th</sup> 2012 the "MONITION AND WARNING" to the Presidency of the Italian Republic, the Presidency of the Council of Ministers, at its home office and PC the O.N.U. in Geneva
- On November 6<sup>th</sup> 2013 ACCREDITATION OF "GUVERNU SARDDU PROVVISORIU" made by MLNS, in compliance with art. 96.3 of the First Geneva Protocol of 1977, in order to manage international relations
- On May 16<sup>th</sup> 2014 the "DENOUNCEMENT AND APPEAL", notified the International Court of Justice, the UN, the International Red Cross and all the member countries to solicit the help of the international community, so as to bring to their attention the serious international offenses committed by the Italian State against the Sardinian Nation, against the Movimentu de Liberatzioni Sarddu (MLNS), and against the Sardinian People, for crimes against humanity, violation of human rights, civil and political rights by the Italian State against the citizens of the Sardinian People Sardinia and against MLNS militants
- On January 20<sup>th</sup> 2015 the "DENOUNCEMENT, ULTIMATUM AND WARNING TO THE ITALIAN FOREIGN occupant" by notifying the Presidency of the Italian Republic, the Presidency of the Italian Council of Ministers, the Italian Ministry of Interior, the Italian Ministry of Defense, the headquarters of UN New York, at the U.N. headquarters in

Geneva, the European Court of Justice, the International Court of Justice, the International Red Cross, to all the prefectures of the Sardinian citizens and all third Countries.

- On April 23, 2015 another "DENOUNCEMENT AND APPEAL" notified the UN, the International Tribunals, the ICRC and all member countries to solicit the help of the international community, by bringing to their attention the serious acts of aggression by the occupying Italian State against the MLNS and, consequently, against all Sardinian People

### THEREFORE REQUESTS:

this court to proceed with the condemnation of ABBANOIA S.p.A for the following offenses:

- to be guilty of serious offenses, with acts of force and repeated aggressions against citizens of the Sardinian People, expressed through illegal and persecutory injunctions and procedures
- to have led to suicide a great number of the Sardinian citizens through illegal and persecutory injunctions and procedures
- to reiterate in criminal intention
- to be a participant in the crimes, not only limited to the conscience and the will of the criminal act, but also including the awareness of how the crime was committed by others
- to have ordered, by exercising its authority, direction and supervision, enforcing subordinate people to commit crimes.
- to have attacked the citizens civil rights
- to have committed acts of fraud, since the act committed, engenders fear in the victim of an imaginary danger or the erroneous belief that they must carry out the order of the Authority
- Abuse of popular credulity with aggravated public disorder

### THE PRINCIPLE OF LIABILITY COLLECTIVE

<< Violations and offenses committed by bodies, officials and / or public servants of the Italian occupying state against Sardinian citizens and / or against the MLNS and its members, integrate international crimes attributable also to the Italian State;

claimed the principle of collective liability, the responsibility for any violation of international law committed by any organ, official and / or agent of the Italian Foreign Occupying State and it is extended to the entire State community, which includes the State itself, all of whom may suffer the consequences of the crime;

as a result, the Foreign Italian Occupying State's responsibility is extended to all involved in such acts of indictment and any act of aggression, force and / or conflict in place against the citizens of the Sardinian people and / or against the MLNS>>

for the following crimes:



Continuous aggravated violations of the "MONITION AND WARNING" of the notification by MLNS to the Italian Foreign State.

To have acted and continue to act with an absolute lack of jurisdiction and also with an absolute lack of competence or absolute incompetence of subject and territory, in the Sardinian National Territory against its citizens, with harassment, robbery, threats and extortion compounded by usury, illegal means, both instrumental and persecutory

- Tax assessments, injunctions for payment and procedures of the coercive collection of taxes, charges and sanctions in the name and on behalf of a foreign Italian occupying state both racist and colonialist and its other public enforcers and / or involved with them.
- Having put in place serious international offenses, such as the repeated acts of force and aggression against citizens of the Sardinian people through illegal persecution injunctions and procedures
- to have led to suicide a number of Sardinian people through illegal procedures and persecutory injunctions

- To have committed crimes against the sovereignty of the People Sardinia, against the territorial integrity and against the Sardinian Nation;
- Having committed the crime of aggravated and continued devastation, looting and killing in the territory of the Sardinian Nation.

### IT ASKS:

This court and the UN Security Council, in their precise function of maintaining peace and in order to avoid the risk of the escalation of public disorder, riots and unpredictability of the sacrosanct "Law of Retaliation" - as required by the rules of international law - due to the exasperation of the population, they shall act to impose the penalties provided in the Italian State and its agency to "ABBANO SPA" for the numerous and repeated offenses committed by its organs, officials and / or its agents MLNS against this and against Sardinian Citizens.


