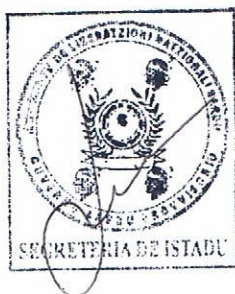

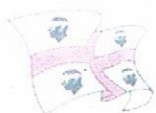

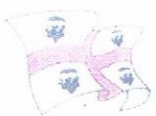
First of all, it builds bases and military servitudes of various types on land, sea and in the sky, limiting transportation, farming and fishing. It let test every kind of weapon contaminating the territory. Consequently, it procures inevitable damage to the health of the people.

Secondly, it manages with indifference the concessions for the installation of activities, industrial contaminating and, furthermore without the beneficiary holdings be provided any guarantees. It pretends to strengthen a genocide of the Sardinian people, using other portions of its territory as to storage site for nuclear waste, despite a referendum that prohibits it.

The Sardinian Nation is forced to undergo persecutors attacks occupying Italian State on our homeland, attacks that are addressed in a particular way to dismember the already precarious economic system of Sardinian Nation with acts of unjustified force against the property of individual and collective of its citizens. The arrogance italian taxes are bringing Sardinian population to despair, putting whole families on the road without having the ability to work and a basic of living that ensures the required.

The Movimentu de Liberatzioni Natzionali Sardu (MLNS) was founded on August the 31st 2011 in order to vindicate the sovereignty of the sardinian people on its land and to bring the Sardinian Nation to free elections in which citizens can have the possibility to elect democratically their representatives. MLNS has always followed the diplomatic way, in absolute respect for international legality and complied with the rules of international law and also italian laws (Law 881/77 of ratification of the pacts of New York of the 1966), but the Italian authorities insist with the abuse of its functions and attack the members of MLNS with pretexts insubstantial.

The foreign occupant Italian State has launched a violent attack against the Movimentu de Liberatzioni Natzionali Sardu under the pretext of a judicial inquiry. This, only in order to be able to assume the existence of circumstances imaginative and offenses nonexistent, such as the constitution of an imaginary military association in alleged violation of an Italian law after the Second World War, the legislative decree of 14 February 1948, n. 43. It intervened heavily in the forces and armament of war against the MLNS. With a sudden incursion has submitted a searching the President and founder of the MLNS, plus a few others belonging to the MLNS and other citizens of the Sardinian people, their homes, places of their jobs and their parque vehicles, by subtracting illegally goods and personal effects and instrumental work, terrorising their families and their acquaintances, and then he seized, segregated and watched over for many hours, subjecting them to informal interrogations and an unprecedented violence moral and psychological.

This situation put in place all the Geneva Conventions and the subsequent additional Protocols from 1949 till today.

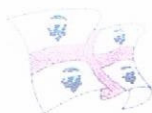


